## Don't wait until Open Season to learn more.

When you become eligible for Medicare, you have the option to switch your enrollment through the Office of Personnel Management (OPM), to a less expensive plan. This change can be made 30 days before you're eligible for Medicare, and any time after.

### **Can I use the same providers? Will my prescriptions still be covered?**

Though you have a new plan option, chances are you may be able to continue seeing your doctors. With Aetna Medicare Advantage, you pay the same cost for any doctor or hospital according to the costs listed on the plan benefits summary. The provider must be eligible to receive Medicare payment and accept the Aetna plan. Please use the resources on [AetnaFeds.com](https://www.aetna.com) to confirm your doctors and prescription drug.
